RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT FOR UNINTERRUPTABLE POWER SUPPLY (UPS) SERVICE MAINTENANCE AND BATTERY REFRESH SERVICES FOR THE SHERIFF'S OFFICE 911 COMMUNICATIONS CENTER, RADIO EQUIPMENT AND INFORMATION TECHNOLOGY SERVER ROOM (FORSYTH COUNTY SHERIFF'S OFFICE)

WHEREAS, National Power Corporation, which is the only company which provides these services, has submitted a quote in the amount of \$53,840 for equipment repair and service maintenance as well as a battery refresh service; and

WHEREAS, it is the recommendation of the County Manager and the Sheriff, that the County enter into a contract with National Power Corporation in the amount of \$53,840 for the uninterruptable power supply (UPS) maintenance services as well as a battery refresh service; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract for uninterruptable power supply (UPS) maintenance services as well as a battery refresh service for the Forsyth County Sheriff's Office, is hereby awarded to National Power Corporation in the amount of \$53,840.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, a contract with National Power Corporation for uninterruptable power supply (UPS) maintenance services as well as a battery refresh service in the amount of \$53,840, pursuant to the terms of the Company's quote, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
