RESOLUTION AUTHORIZING EXECUTION OF A GRANT AGREEMENT WITH OLD SALEM, INCORPORATED FOR PRESERVATION AND RESTORATION OF THE HISTORIC BOYS' SCHOOL ON SALEM SQUARE UTILIZING THE REVENUES APPROPRIATED BY THE FORSYTH COUNTY BOARD OF COMMISSIONERS PURSUANT TO THE PROVISIONS OF N.C.G.S. 153A-437

WHEREAS, Old Salem, Incorporated, a local historic museum, has adopted and presented to Forsyth County a Resolution requesting an appropriation of \$1,500,000 to be used for the preservation and restoration of the Historic Boys' School on Salem Square at Old Salem pursuant to the provisions of N.C.G.S. 153A-437; and

WHEREAS, Old Salem, Incorporated will comply with the applicable bidding laws in the construction of the Boys' School facility; and

WHEREAS, the Forsyth County Board of Commissioners has appropriated the requested funds and now proposes to consider authorizing execution of the associated grant agreement;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, the attached Grant Agreement between Forsyth County and Old Salem, Incorporated in the amount of \$1,500,000, for the preservation and restoration of the Historic Boys' School on Salem Square at Old Salem, subject to compliance by Old Salem, Incorporated with the applicable bidding laws in the construction of the Boys' School facility, a preaudit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.

THIS AGREEMENT, made and entered into as of the <u>lst</u> day of <u>July 2016</u> by and between FORSYTH COUNTY as grantor (hereinafter referred to as the COUNTY) AND <u>OLD SALEM</u>, <u>INCORPORATED</u>. (hereinafter referred to as the GRANTEE), pursuant to and subject to the restrictions and conditions set forth herein;

WITNESSETH:

In consideration of receipt of a grant or appropriation of funds from Forsyth County for the year 7/1/2016 - 6/30/2017, in an amount not to exceed \$1,500,000.00, the GRANTEE named hereinabove does hereby agree to abide by the terms of this Agreement as set forth herein.

In consideration of the above, the parties do hereby agree as follows:

- Agreement and perform services in consideration of the receipt of funds in accordance with the purposes and/or under the restrictions and conditions as attached to this Agreement and incorporated herein by reference. The GRANTEE further agrees to expend the County funds in accordance with the Budget for said funds attached hereto and which is incorporated herein by reference. Funds made available to the GRANTEE pursuant to this Agreement shall be expended only in accordance with applicable federal, state and local laws. No change or alteration in the COUNTY amount of the total Budget attached may be made without the express approval of the County.
- (2) Termination of this Agreement may occur for reasons described herein or in attachments hereto. The COUNTY may execute an extension of this Agreement in its discretion and in accordance with such additional conditions as it may require.
- The GRANTEE agrees that it will supply such records, information and verification relating to expenditures of the funds or the operations of the GRANTEE as may reasonably be requested by the COUNTY. The GRANTEE agrees that the COUNTY shall have access to the records and premises of the GRANTEE at all reasonable times, and the GRANTEE agrees to submit such reports as the COUNTY shall request pertaining to the funds granted herein or the operations of the GRANTEE. The GRANTEE

shall maintain a written accounting and documentation of all of its receipts and disbursements relating to the grant funds which are the subject of this Agreement. The COUNTY reserves the right to require a certified audit pertaining to the use of the grant funds, or may perform the audit through the use of its staff. The GRANTEE agrees to subject itself to the provisions of Article 33C of Chapter 143 of the North Carolina General Statutes, entitled "Meetings of Public Bodies," to the same extent as the COUNTY.

- (4) The GRANTEE shall furnish to the COUNTY a copy of its annual audit report performed by a certified public accountant as soon as such becomes available to the GRANTEE but no later than 6 months following the GRANTEE's fiscal year end.
- (5) Funds will be disbursed to the GRANTEE by reimbursement to the GRANTEE for expenses incurred in accordance with the attached budget, unless otherwise specified in the attachments. Monthly disbursements by the COUNTY shall not exceed 1/12 of the proposed annual grant amount of COUNTY funds. Quarterly disbursements by the COUNTY shall not exceed 1/4 of the proposed annual grant amount of COUNTY funds.
- (6) The County may suspend or terminate the payment of grant funds in whole or in part for any violation of this Agreement. Suspension or termination may be effected for the following reasons as determined by the COUNTY, but not limited to these reasons:
 - (a) Ineffective or improper use of grant funds;
 - (b) Failure to comply with the terms and conditions of the Agreement;
 - (c) Submission to the COUNTY of reports which are incorrect or incomplete in any material respect;
 - (d) Frustration or impossibility of performance, rendering the carrying out of this
 Agreement improper or infeasible.
 - (e) Any violation of this Agreement.
 - (f) In the opinion of the COUNTY, the COUNTY's financial situation makes it impractical to provide the grant funds.

In addition, the COUNTY may suspend or terminate payment of grant funds if the GRANTEE fails to make satisfactory progress toward meeting the project services which are the subject of this Agreement;

and the determination of whether satisfactory progress has been made shall be in the discretion of the COUNTY.

If for any reason the payment of grant funds is suspended or terminated, the GRANTEE agrees to promptly remit to the COUNTY any payments previously received by the GRANTEE which the COUNTY deems to have been paid and received in violation of this Agreement.

- (7) Any and all alterations in the restrictions and conditions upon the grant of the funds herein or alterations in the amount of this Budget attached hereto shall be subject to prior review and written approval by the COUNTY.
- (8) This Agreement and the grant funds which are the subject of this Agreement are expressly nonassignable without the prior written consent and approval of the COUNTY.
- (9) Non-expendable property purchased under this Agreement shall remain the property of the GRANTEE, unless the attached conditions or Budget provide that such property shall become the property of the COUNTY.
 - (10) The attached Exhibits are:
 - (a) The Budget;
 - (b) Purposes and/or Restrictions and Conditions; and
 - (c) Reporting Requirements, which are incorporated herein by reference.

IN WITNESS WHEREOF, the COUNTY has caused this Agreement to be duly executed in its behalf, and the GRANTEE has caused the same to be duly executed in its behalf as of the date first above written.

OLD SALEM, INCORPORARED

RESTRICTIONS AND CONDITIONS

FY 2016-2017

PURPOSE: The purpose of the Grantee is to provide support for the restoration of the Boys' School at Old Salem, Incorporated

- 1. Payment to the Grantee will be made upon receipt of a report of Grantee expenses and receipts for the preceding period completed.
- 2. If the Grantee lacks sufficient funds to operate prior to payment by the County, arrangements may be made for an advance of County funds based on a report of the Grantee's current financial condition and an estimate of expenditures for the period of the advance requested.
- 3. The Board of Commissioners is concerned that the County's very strong financial condition at present may create unrealistic expectations among some Grantee organizations that County financial support will continue indefinitely, or regularly increase in the future. There may also be a perception in the community that the County is always a likely source of financial assistance for various capital fund drives or special projects. The County's first priorities must always be those services and functions which counties are required by law to provide. Because the County's revenues are very responsive to changes in the local economy, even a slight economic downturn might require a reduction or withdrawal of County support for such organizations, projects and fund drives.
- 4. Grantee organizations shall immediately notify the County of any substantive changes in their other sources of financial support which might cause them to seek additional County funding in the current year, or in future years, which County funding may not be forthcoming or available.
- 5. The Grantee agrees to hold the County harmless from liability for any expenses which may be claimed against the County due to the administration of the Grantee's program.
- 6. Grantee and it subcontractors shall comply with Article 2 of Chapter 64 of the North Carolina General Statutes relating to the required use of the federal E-Verify program to verify the work authorization of newly hired employees. Failure of the Grantee to comply with the provision or failure of its subcontractors to comply could render this contract void under North Carolina law.
- 7. In accordance with N.C.G.S. §147-86.59 and other applicable sections of N.C.G.S. §147-86.55 et seq., the Iran Divestment Act of 2015, each Party hereby certifies that it is not identified on the State Treasurer's list of persons which the Treasurer has determined engage in investment activities in Iran, including any subcontractors hereunder of either Party.

REPORTING REQUIREMENTS

FY 2016-2017

- 1. Grantee shall submit to Forsyth County a quarterly report which shall include but not be limited to the following:
 - A. Financial statement showing revenue and the source, and line item expenditures compared with the approved budget.
 - B. Report of activities and programs indicating the amount of progress toward meeting the objectives for the restoration of the Boys' School.
 - C. Report showing the number visitors to Old Salem, and the organization's impact on the local community.
- 2. Prior to the final payment, Grantee shall provide an evaluation of the overall Old Salem's programs and its impact on the total community.

Dear Mr. Watts:

Old Salem seeks an appropriation of \$1.5 million to assist with the restoration of the Boys' School on Salem Square. Enclosed please find the Resolution ratified by our board of directors this morning.

The oldest school building in Forsyth County, the Boys' School was built in 1794 to provide classroom instruction for Moravian boys, ages 6-14. The building, currently vacant, has plenty of life left in it and awaits its transformation into a center of excellence in which to tell the story of education in early Salem. Old Salem plans to 1) restore the building to preserve its unique historic architecture and update necessary infrastructure, and 2) introduce exciting new educational programming incorporating videos, hands-on activities, reproduction objects, and a reconstructed period classroom where daily lessons—drawn from the original dairies of schoolteacher Peter Wolle—will be shared with visitors. Second-floor classrooms will be used for in-depth experiential learning for students and intensive teacher training workshops. Enclosures provide more information about our plans.

Partnership with Forsyth County in the restoration of the Boys' School would be mutually beneficial. For Old Salem, the completion of the Boys' School will

- Allow Old Salem to preserve a significant historic property within its footprint that is among its few remaining original 18th-century buildings.
- Enable us to expand our story to more fully tell the story of education in early Salem affording education to both young boys and girls.
- Add an interpretive site to our tour schedule, building capacity for this institution by attracting new audiences and increasing visitation.

For Forsyth County, the completion of the Boys' School will

- preserve an historic property that is significant not only in Forsyth County, but nationally, as the oldest Moravian school building still standing and among the earliest existing schools in the U.S. built specifically for pre-collegiate education.
- add to and enhance the trove of educational experiences for Forsyth County students, teachers, and residents.
- provide critical teacher training workshops in history, the social sciences, and the arts for Forsyth County teachers.
- further contribute to and enhance the economic development and prosperity of Forsyth County.

WHEREAS, Old Salem, Inc. (dba Old Salem Museums & Gardens) plans to (1) restore the building to preserve its unique historic architecture and to update its necessary infrastructure, (2) develop the site as a center of excellence in which to tell the story of education in Salem extended to both young boys and girls, (3) introduce exciting new educational programming incorporating videos, hands-on activities, reproduction objects and a reconstructed period classroom, where daily lessons drawn for the original diaries of schoolteacher Peter Wolle will be shared with visitors on the first floor, and (4) provide second-floor classrooms to be used for in-depth experiential learning for students and intensive teacher training workshops; and

WHEREAS, the Restoration Project will (1) drive additional tourism to Forsyth County, (2) expand Old Salem's capacity to serve additional school groups, and (3) provide new teacher training space and programs; and

WHEREAS, the Restoration Project was approved by the Historic Resource Commission on May 4, 2016; and

WHEREAS, the total budget for the Restoration Project is \$2,445,000, including \$517,000 for educational programming and \$1,928,000 for the restoration of the Boys' School Building, outbuildings and grounds.

NOW, THEREFORE, BE IT RESOLVED, that, pursuant to NCGS Sec. 153A-427, Assistance to historical organizations, a request for \$1,500,000 from Forsyth County, North Carolina towards the restoration of the Boys' School building, outbuildings and grounds hereby is ratified and approved.
