RESOLUTION MAKING CERTAIN **FINDINGS** AND DETERMINATIONS AND AUTHORIZING AND RATIFYING THE FILING OF AN APPLICATION WITH THE LOCAL GOVERNMENT COMMISSION IN CONNECTION WITH THE PROPOSED ISSUANCE **OF** GENERAL **OBLIGATION** SCHOOL BONDS, **GENERAL OBLIGATION COMMUNITY COLLEGE** BONDS, GENERAL **OBLIGATION** PARKS AND RECREATION BONDS, **GENERAL OBLIGATION PUBLIC FACILITIES BONDS** AND GENERAL **OBLIGATION COURTHOUSE BONDS** BY THE COUNTY FORSYTH, NORTH CAROLINA

BE IT RESOLVED by the Board of Commissioners (the "Board of Commissioners") for the County of Forsyth, North Carolina (the "County"):

Section 1. The Board of Commissioners does hereby determine that:

- (a) Preliminary studies have been completed to demonstrate the need for improvements to the public schools, community colleges, parks and recreational facilities, courthouse facilities and other public facilities of the County.
- (b) The Board of Commissioners wishes to commence the procedures for the issuance of not to exceed \$8,500,000 General Obligation School Bonds, \$2,300,000 General Obligation Community College Bonds, \$2,000,000 General Obligation Parks and Recreation Bonds, \$4,000,000 General Obligation Public Facilities Bonds and \$5,000,000 General Obligation Courthouse Bonds at this time.
- (c) The annual audits of the County show the County to be in strict compliance with debt management policies and that the budgetary and fiscal management policies are in compliance with law.
- Section 2. The filing of an application of the County with the North Carolina Local Government Commission for approval of the issuance of said General Obligation School Bonds, General Obligation Community College Bonds, General Obligation Parks and Recreation Bonds, General Obligation Public Facilities Bonds and General Obligation Courthouse Bonds of the County is hereby authorized, ratified and approved.
- Section 3. The law firm of Womble Carlyle Sandridge & Rice, LLP is hereby appointed to serve, but solely at the pleasure of the Board of Commissioners, as bond counsel to the County in connection with the authorization, sale and issuance of the said bonds.
- Section 4. DEC Associates, Inc. is hereby appointed to serve, but solely at the pleasure of the Board of Commissioners, as financial advisor to the County in connection with the sale and issuance of the said bonds.
 - Section 5. This resolution shall take effect immediately upon its passage.
