RESOLUTION APPROVING THE FIRST REVISION TO THE COMMUNITY-BASED JUVENILE DELINQUENCY, SUBSTANCE ABUSE, AND GANG PREVENTION PLAN AND AUTHORIZING ITS SUBMISSION FOR STATE APPROVAL AND IMPLEMENTATION IN FISCAL YEAR 2016-2017 (JUVENILE CRIME PREVENTION COUNCIL)

WHEREAS, on June 27, 2016, the Forsyth County Board of Commissioners adopted a Resolution Approving the Community-Based Juvenile Delinquency, Substance Abuse, and Gang Prevention Plan and Authorizing Its Submission for State Approval and Implementation for the 2016-2017 fiscal year; and

WHEREAS, on November 21, 2016, the Forsyth County Juvenile Crime Prevention Council approved the attached revised funding recommendations for fiscal year 2017; and

WHEREAS, the North Carolina Department of Public Safety, Division of Juvenile Justice requires that the Board of County Commissioners approve the revised funding plan prior to its submittal for State approval; and

WHEREAS, based on the proposed revised plan recommended by its Allocations Committee, the Juvenile Crime Prevention Council of Forsyth County approved and hereby submits to the Forsyth County Board of Commissioners the attached plan for the re-allocation of juvenile delinquency, substance abuse, and gang prevention funds for fiscal year 2016-2017.

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners having reviewed the attached proposed revisions of the community-based juvenile delinquency, substance abuse, and gang prevention plan approved and submitted by the Juvenile Crime Prevention Council of Forsyth County and finding it acceptable, hereby approves the said revised plan and further authorizes the plan to be submitted to the North Carolina Department of Public Safety, Division of Juvenile Justice for final approval and subsequent implementation for fiscal year 2016-2017.

BE IT FURTHER RESOLVED that the Chairman of the Forsyth County Board of Commissioners is hereby authorized to execute all necessary documents to submit and implement the above revised plan.

The Forsyth County JCPC met on November 21, 2016 and voted to approve the below revised funding recommendation for consideration by the Board of County Commissioners. The Children's Home has been absorbed by The Crossnore School. The existing contract with The Children's Home will be terminated and a new contract executed with The Crossnore School. The reduction in funding is based on The Crossnore School serving a significantly lower amount of children then the original allocation.
