RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF LAW ENFORCEMENT UNIFORM GARMENTS AND ASSOCIATED SERVICES (FORSYTH COUNTY SHERIFF'S OFFICE)

WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 10:00 a.m., Monday, November 7, 2016 for the purchase of law enforcement uniform garments and associated services as outlined in Attachment A, which is attached hereto and incorporated herein by reference, for the Forsyth County Sheriff's Office, and the following bids were received:

Read's Uniforms, Inc. \$76,285.96 American Uniform Sales, Inc. \$80,130.00 Sam's On The Market, Inc. \$101,778.00

; and

WHEREAS, it is the recommendation of the County Manager, the Sheriff, and the Purchasing Director that a contract for the purchase of law enforcement uniform garments and associated services as outlined in Attachment A be awarded to Read's Uniforms, Inc. in the amount of \$76,285.96; and

WHEREAS, the terms of the bid reserve for the County the right to purchase additional uniform garments at bid prices from January 1, 2017 through December 31, 2017, and at an increased amount not to exceed 3% per year from January 1, 2018 through December 31, 2019; and

WHEREAS, the vendor shall notify the County by October 1, immediately preceding the extension year, of any price increases.

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners that a contract for the purchase of law enforcement uniform garments and associated services as outlined in Attachment A for the Forsyth County Sheriff's Office, is hereby awarded to Read's Uniforms, Inc., in the amount of \$76,285.96.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, a contract with Read's Uniforms, Inc. and any other necessary documents for the purchase of law enforcement uniform garments and associated services as outlined in Attachment A for the Forsyth County Sheriff's Office, pursuant to the terms of the bid, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.

CONTRACT

FORSYTH COUNTY)

THIS CONTRACT, made and entered into effective the 1st day of January 2017, by and between Forsyth County, North Carolina (the "County") on behalf of the Forsyth County Sheriff's Office (the "Sheriff's Office"), and Read's Uniforms, Inc. (the "Provider");

WITNESSETH

WHEREAS, the County duly advertised for bids to purchase uniforms and bids were received and duly opened on November 7, 2016, and;

WHEREAS, after careful consideration of the bid submitted by the Provider, it is the recommendation of the County Manager, the Sheriff and the Purchasing Director that a contract for the purchase of uniform garments and associated services be awarded to the Provider in the amount of \$76,285.96.

NOW, THEREFORE, in consideration of the premises and in further consideration of the mutual agreement contained herein, as well as the financial consideration hereinafter referred to, the parties hereto do contract and agree as follows:

- (1) For the purpose and subject to the terms and conditions hereinafter set forth, the County hereby contracts for the purchase of uniform garments and associated services from the Provider, and, the Provider agrees to provide the uniform garments and associated services to the County in accordance with the terms of the Contract.
- (2) In accordance with the County's specifications (Attachment A), incorporated herein by reference, and the Provider's submitted proposal (Attachment B), also incorporated herein by reference, the Provider agrees to deliver to the County the uniform garments bid and described in the County specifications and in the Provider's submitted proposal.
- (3) The County's specifications outlined in the Invitation for Bid, and the proposal thereon by the Provider, all of which are on file in the office of the City/County Purchasing Department and further are incorporated into and made a part of this contract by reference, shall constitute the contract between the parties as though full written herein for the purchase of uniform garments and associated services.

- (4) As full compensation to the Provider for the purchase of uniform garments and associated services, the County agrees to pay Provider a sum not-to-exceed of Seventy-six Thousand Two Hundred and Eighty-Five Dollars and Ninety-Six Cents (\$76,285.96) for the period of January 1, 2017 through December 31, 2017 upon delivery and final acceptance.
- (5) The Provider shall bill the County for uniform garments received. The County shall pay all such bills within the following thirty (30) days provided all elements of the Contract are satisfactorily met.
- (6) As per the County's specifications, Conditions of Quotation, Section 8, the term of this Agreement shall be effective January 1, 2017 and ending December 31, 2017. By mutual agreement, the contract may be automatically extended for an additional term of one (1) year for up to a total of two (2) additional years ending December 31, 2019.
- (7) As per the County's specifications, Conditions of Quotation, Section 8, the prices set forth in this contract are firm for the period beginning January 1, 2017 and ending December 31, 2017. Contract prices for any extension year shall not exceed 3.0%. The vendor shall notify FCSO by October 1, immediately preceding the extension year, of any price increases.
- (8) To the fullest extent permitted by law, the Provider shall defend, indemnify, and hold harmless Forsyth County, its Officials, Officers, and Employees from and against all claims, damages, loss and expenses, including but not limited to attorney's fees, arising out of any act or omission of the Provider or his employees in the execution, performance, or failure to adequately perform the obligations pursuant to this agreement.

The Provider shall not be treated as an employee with respect to the services performed hereunder for federal or state tax, unemployment or workers' compensation purposes. The Provider understands that neither federal, nor state, nor shall payroll tax of any kind be withheld or paid by the County on behalf of the Provider or the employees of the Provider. The Provider further understands and agrees that the Provider is fully responsible for the payment of any and all taxes arising from the payment of monies under this Agreement.

The Provider shall not be treated as an employee with respect to the services performed hereunder for purposes of eligibility for, or participation in, any employee pension, health, or other fringe benefit plan of the County.

The County shall not be liable to the Provider for any expenses paid or incurred by the Provider unless otherwise agreed in writing.

The Provider shall maintain, at its sole expense, such insurance coverage as required by the Forsyth County Risk Manager. The Provider shall maintain, at its sole expense, the following minimum insurance coverage:

- A. <u>Commercial General Liability Insurance</u>. The Provider shall maintain occurrence version commercial general liability insurance or equivalent form with a limit of not less than \$1,000,000 each occurrence. If such insurance contains a general aggregate limit, it shall apply separately to this agreement or be no less that two times the required occurrence limit. Such insurance coverage shall:
 - Include the County, its officials, officers, and employees as additional insured with respect to performance of the Services, except for the negligence or willful misconduct of the Additional Insured(s).
 - 2. **Be primary** with respect to any insurance or self-insured retention programs covering the County, its officials, officers, and employees, as to Provider's liability.
- B. <u>Business Automobile Liability Insurance</u>. The Provider shall maintain business automobile liability insurance or equivalent form with a limit of not less than \$1,000,000 each accident. Such insurance shall include coverage for hired, and non-owned automobiles.
- C. <u>Workers' Compensation and Employers' Liability Insurance.</u> The Provider shall maintain workers' compensation insurance with North Carolina statutory limits and employers' liability insurance with limits of not less than \$500,000 each accident.
 - D. Other Insurance Requirements. The Provider shall:
 - Prior to commencement of services, furnish the County with properly executed Certificates of Insurance which shall clearly evidence all insurance required in this section.
 - 2. Replace certificates for any such insurance expiring prior to completion of the services.

- 3. Maintain such insurance from the time services commence until services are completed.
- 4. Place such insurance with insurers authorized to do business in North Carolina and having A. M. Best Company ratings of not less than A:VII. Any alternatives to this requirement shall require written approval of the County's Risk Manager.

E. The Provider understands and acknowledges that these insurance coverage requirements are minimums and that they do not restrict or limit the hold harmless provisions of this agreement.

(9) No late payment or other amounts, designated penalties, liquidated damages, attorneys fees, court costs or charges shall apply to this contract.

No stated laws of a particular state or jurisdiction shall apply to or govern this contract other than the applicable laws of the State of North Carolina; and no forum selection of the place, courts, or judicial body of a particular state or jurisdiction shall apply.

Involuntary or binding mediation, arbitration, negotiation, or other settlement procedure of disputes, if any, shall not apply to this contract.

The Provider shall supply, at its sole expense, all equipment, tools, materials, and/or supplies required to provide contracted services unless otherwise agreed in writing.

The provider and its subcontractors shall comply with Article 2 of Chapter 64 of the North Carolina General Statutes relating to the required use of the federal E-Verify program to verify the work authorization of new hired employees. Failure of the provider to comply with this provision or failure of its subcontractors to comply could render this contract void under North Carolina law. It is the expectation of Forsyth County that the provider will comply with all applicable federal immigration laws in its hiring and contracting practices relating to the services covered by this contract involving County funds, as outlined in the Resolution adopted by the Forsyth County Board of Commissioners at its regular meeting of October 23, 2006.

Provider hereby certifies that it and its subcontractors are not on the North Carolina State Treasurer's list of persons engaging in business activities in Iran, prepared pursuant to NCGS §143C-6A-4, nor will Provider utilize on this agreement any subcontractor on such list.

The Provider has no authority to enter into contracts or agreements on behalf of the County.

The Provider declares that it has complied with all federal, state and local laws regarding business permits, certificates, and licenses that may be required to carry out the services to be performed under this Agreement.

The Provider agrees to comply with all state and federal occupational safety and health laws, regulations and standards relating to services covered by this contract.

The Provider agrees to comply, with all applicable federal immigration laws in its hiring and contracting practices relating to the services covered by this contract involving County funds, as outlined in the Resolution adopted by the Forsyth County Board of Commissioners at its regular meeting of October 23, 2006.

(10) Unrestricted Termination. Either party may terminate this Contract at any time, for any reason or without cause, upon not less than 90 days prior written notice to the other party. Concerning the Sheriff's Office, written notice may be delivered to the Sheriff's Office Business Manager, Mr. Randy Hunsucker at 301 North Church Street, Winston Salem, NC 27101. Concerning Read's Uniforms Inc., written notice may be delivered to Shannon D. Hutzler, Chief Operating Officer, 123 Sweeten Creek Road, Suite D, Asheville, NC 28803.
