WHEREAS, Forsyth County owns a certain motor vehicle, identified as a 2006 GMC Sport Utility Vehicle with more than 150,000 miles, VIN# 3GKGK26U16G127332, which vehicle is surplus, obsolete, or unused and is therefore no longer economically beneficial to the County and should be declared surplus to the County's needs; and
