## **EXPLANATION:**

The Forsyth County Sheriff's Office's 2016 State Criminal Alien Assistance Program (SCAAP) grant award has an unspent fund balance of \$229,064 as of June 30, 2017, which needs to be appropriated into the Sheriff's Office budget.
