SUMMARY	OF INFORMATION:			
On September 28, 2015, the Forsyth County Board of Commissioners adopted a resolution approving and authorizing \$1,500,000 in County funds to be reserved from General Fund Balance to assist the Airport Commission of Forsyth County with required local matching funds under proposed grants from the North Carolina Department of Transportation and the Federal Aviation Administration to fund the following three capital projects at Smith Reynolds Airport:				
 Taxiway Foxtrot Extension Design and Partial Construction Clear Terrain Obstructions East of Runway 15-33 Taxiway Alpha Relocation 				
According to the Resolution, these funds will be repayable to Forsyth County by the Airport Commission of Forsyth County at 0% interest in up to a 10-year period. The funds have been set aside and reserved in fund balance as provided in the Resolution should the Airport Commission of Forsyth County need them as these projects are initiated. The Airport Commission is now requesting \$300,000 of the \$1,500,000 in order to ensure it has cash flow to pay for projects and operating costs.

FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO FY 2017-2018 BUDGET ORDINANCE

EXPLANATION:

On September 28, 2015, the Forsyth County Board of Commissioners adopted a resolution approving and authorizing \$1,500,000 in County funds to be reserved from General Fund Balance to assist the Airport Commission of Forsyth County with required local matching funds under proposed grants from the North Carolina Department of Transportation and the Federal Aviation Administration to fund the following three capital projects at Smith Reynolds Airport:

- Taxiway Foxtrot Extension Design and Partial Construction
- Clear Terrain Obstructions East of Runway 15-33
- Taxiway Alpha Relocation
