WHEREAS, the bid offered by Performance Automotive Group, Inc. for a Dodge Durango is provided through the North Carolina Sheriff's Association Group Purchasing Program, a competitive bidding group purchasing program, which is a formally organized program that offers competitively obtained purchasing services at discount prices to two or more public agencies, in compliance with N.C.G.S. 143-129(e)(3); and

WHEREAS, it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of five all-wheel drive 2018 Dodge Durango SUVs in the amount of \$25,842 each be awarded to Performance Automotive Group, Inc. for a total amount of \$129,210; and

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners that a contract for the purchase of five all-wheel drive 2018 Dodge Durango SUVs in the amount of \$25,842 each is hereby awarded to Performance Automotive Group, Inc. in the total amount of \$129,210 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Performance Automotive Group, Inc. for the purchase of five all-wheel drive 2018 Dodge Durango SUVs consistent with the County's specifications and the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
