RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION TO THE NORTH CAROLINA DEPARTMENT OF COMMERCE TO APPLY FOR AND ACCEPT, IF AWARDED, A BUILDING REUSE GRANT TO BENEFIT LIGHTHOUSE LOGISTICS INC.

WHEREAS the Forsyth County Board of Commissioners desires to assist in economic development efforts for business and industry within Forsyth County;

WHEREAS the Board fully supports the proposed project by Lighthouse Logistics Inc., which will result in the renovation and reuse of a facility located at 3803 Kimwell Drive, Winston-Salem, and will create a minimum of 22 new jobs in Forsyth County;

WHEREAS North Carolina General Statute 143B-472.127 authorizes local governments to apply for and receive grants from the Rural Economic Development Division of the North Carolina Department of Commerce to benefit private companies that will productively reuse or demolish buildings and properties, and the Forsyth County Board of Commissioners wishes to submit a formal application for Building Reuse funds in the amount of \$50,000 from the North Carolina Department of Commerce to benefit Lighthouse Logistics Inc.; and

WHEREAS the Board certifies that Forsyth County will provide a matching grant of \$2,500, representing 5% of the State grant pursuant to N.C.G.S. 143B-472.127(a)(3), and will meet all other requirements of the North Carolina Department of Commerce;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to submit a formal application to the North Carolina Department of Commerce in order to provide assistance to benefit Lighthouse Logistics Inc., for reuse of a building and, if the grant is awarded, to execute such documents necessary, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney, to accept the grant and provide a matching grant of \$2,500 to Lighthouse Logistics Inc.
