RESOLUTION APPROVING THE SECOND REVISION TO THE FISCAL YEAR 2018-SUBJECT: 2019 HOME AND COMMUNITY CARE BLOCK GRANT COUNTY FUNDING PLAN FOR OLDER ADULTS AND AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS TO SUBMIT THE REVISED PLAN FOR STATE APPROVAL (AGING SERVICES)

COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:

SUMMARY OF INFORMATION:

The Forsyth County Aging Services Planning committee recommended a second revision to the Fiscal Year 2018-2019 Home and Community Care Block Grant (HCCBG) County funding plan based on the release of \$45,000 from the Department of Social Services for Level I services. Staffing vacancies will not allow the department to be able to draw down the full HHCBG allocation therefore to maintain program fidelity and address needs in other agencies, the department released \$45,000.

A request for funding proposals was sent out to current providers and at its April 26, 2019 Advisory Committee meeting, the HCCBG Board approved the revised plan. Of the \$45,000 released by DSS, Senior Services, Inc. received \$30,167 for additional funding for the Meals on Wheels program (\$20,000), Level 2 Personal Care (\$5,167), and Information & Options Counseling (\$5,000); the Shepherd Center of Greater Winston-Salem received \$7,667 for its Senior Center operations; and Senior Financial Care received \$7,166.

The attached resolution authorizes the submission of the second revised HCCBG plan to the State by the Piedmont Triad Regional Council which is the Lead Area Agency on Aging for Forsyth County.

NOW, THEREFORE, BE IT RESOLVED, that Board of Commissioners of Forsyth County hereby approves the attached revised Fiscal Year 2018-2019 Home and Community Care Block Grant County Funding Plan for older adults and authorizes its submission to the North Carolina Department of Health and Human Services, Division of Aging through the Piedmont Triad Regional Council designated as the Forsyth County Area Lead Agency on Aging for approval; and

BE IT FURTHER RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, any necessary documents to submit the said revised Funding Plan to the State, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
