RESOLUTION AUTHORIZING EXECUTION OF A SERVICE AGREEMENT BETWEEN FORSYTH COUNTY AND WAKE FOREST UNIVERSITY BAPTIST MEDICAL CENTER FOR TRAUMATIC EVENT COUNSELING SERVICES

WHEREAS County employees in various departments are increasingly encountering trauma in the workplace and home;

WHEREAS unique and high-level sensory exposures can lead to chronic stress, increased absences and difficulty retaining quality employees;

WHEREAS Wake Forest University Baptist Medical Center, through its FaithHealth Division, has created a team of first responder, interfaith/non-secular chaplains to serve not only first responders but all County employees; and

WHEREAS on October 4, 2018, the Forsyth County Board of Commissioners approved expansion of the first responder chaplaincy program to all County departments;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners that a contract for traumatic event counseling services for Forsyth County is hereby extended for an additional year in the amount of \$75,000.00.

BE IT FURTHER RESOLVED, that the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, a contract with Wake Forest University Baptist Medical Center for traumatic event counseling services for Forsyth County in the amount of \$75,000.00, and to execute up to two one-year renewals, within budgeted appropriation, in the future fiscal years for a maximum of three (3) years duration, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
