RESOLUTION RATIFYING AND AUTHORIZING EXECUTION OF AN INTERLOCAL AGREEMENT WITH THE TOWN OF WALKERTOWN TO PROVIDE FIRE INSPECTION SERVICES

WHEREAS N.C.G.S. §160A-461 provides that any unit of local government in this State and any other unit of local government in this State may enter into contracts or agreements with each other to execute any undertaking;

WHEREAS the Town of Walkertown ("Town") desires to have Forsyth County ("County") provide Residential Building Fire Inspections, Commercial Building Fire Inspections, Construction and Permit Fire Inspections, and Arson Investigations (collectively "Inspection Services") within the municipal limits of the Town, and the County desires to provide such Inspection Services; and

WHEREAS the cost to the County to provide such Inspection Services for the fiscal year beginning July 1, 2020, will be \$37,194, and the Town has agreed to pay the County such amount;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager, in coordination with the Clerk to the Board, to execute an interlocal agreement between Forsyth County and the Town of Walkertown to provide Inspection Services within the Town, in substantially the same form as the attached agreement, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney;

- **BE IT FURTHER RESOLVED,** that the Forsyth County Board of Commissioners hereby terminates any provision of any prior interlocal agreement with the Town regarding any obligation of the County to provide any fire inspections or fire protection services to the Town; and
- **BE IT FURTHER RESOLVED**, that this resolution ratifying interlocal cooperation between Forsyth County and the Town of Walkertown is hereby spread upon the minutes of the Forsyth County Board of Commissioners.

ORTHOGRAPH (AGREEMENT FORSYTH COUNTY)

THIS INTERLOCAL AGREEMENT, made and entered into this the 1st day of July, 2020, by and between FORSYTH COUNTY, hereinafter referred to as the "County," and THE TOWN OF WALKERTOWN, hereinafter referred to as the "Town";

WITNESSETH:

WHEREAS N.C.G.S. §160A-461 provides that any unit of local government in this State and any other unit of local government in this State may enter into contracts or agreements with each other to execute any undertaking;

WHEREAS N.C.G.S. §160A-461 requires that such contracts and agreements "shall be of reasonable duration, as determined by participating units;"

WHEREAS Section 2 of the 1984 Interlocal Agreement between the County and the Town has no defined duration and has been deemed no longer of reasonable duration and needing clarification;

WHEREAS N.C.G.S. §160A-461 authorizes the County to contract for and subsequently provide to the Town the following services: Residential Building Fire Inspections, Commercial Building Fire Inspections, Construction & Permit Fire Inspections, and Arson Investigations, hereinafter referred to as "Inspection Services";

WHEREAS, under the terms of this agreement, the County will provide Inspection Services within the municipal boundaries of the Town;

NOW, THEREFORE, in consideration of the premises and of other good and valuable considerations, the parties hereto contract and agree as follows:

1. The County agrees that it will provide Inspection Services to the Town beginning July 1, 2020.

2. The Town agrees to pay the County \$37,194 for the fiscal year ending June 30, 2021. The

fee shall increase 2% in each subsequent fiscal year. The Town shall pay the County quarterly

payments to be made no later than 15 days after the beginning of each quarter.

3. The County shall furnish adequate Inspection Services within the Town in accordance with

Inspection Services provided in Tax Districts and shall provide the equipment, personnel, and all

other resources necessary for furnishing Inspection Services in the Town. The services shall be in

accordance with standards set forth by the Forsyth County Fire Marshal and the North Carolina

Department of Insurance.

4. Forsyth County shall retain any ancillary fees received from inspected entities for Inspection

Services rendered during the course of the Agreement.

5. This Interlocal Agreement for Inspection Services can be terminated by either party upon a

180-day notice from either party.

6. This agreement shall become effective July 1, 2020, and shall continue from fiscal year to

fiscal year, and notwithstanding anything to the contrary herein, shall terminate no later than June 30,

2025.

7. Notice. All notices permitted or required to be given by one party to the other party shall

be addressed and delivered in writing as follows:

8. This Agreement shall be governed by the laws of the North Carolina, except that provisions regarding conflict of laws shall not apply. The venue for any legal proceeding shall be in Forsyth County, North Carolina. This Agreement shall supersede all prior agreements between the parties relating to Inspection Services, and the County has no obligation, outside of the services contracted for in this Agreement, to provide any fire services or Inspection Services to the Town. No action or failure to act by the County shall constitute a waiver of any of its rights or remedies or as approval or acquiescence in a breach thereunder, except as may be specifically agreed in writing. This agreement is intended for the benefit of the County and the Town. If any provision of this Agreement shall be unenforceable, the remainder of the Agreement shall be enforceable to the extent allowed by law.

IN TESTIMONY WHEREOF, the County has caused this instrument to be executed by the Chairman of the Board of County Commissioners, attested by the Clerk to the Board of County Commissioners, and the County Seal affixed thereto; and the Town has caused this instrument to be signed in its name by its Mayor, attested by its Secretary, and its municipal seal hereto affixed, all by authorization of its Town Councilmembers duly given.
