FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2020-2021 BUDGET ORDINANCE

EXPLANATION:

On November 28, 2016, the Forsyth County Board of Commissioners approved the transfer of \$60,000 to the Community & Economic Development Department as a result of the year-end operating results from Fiscal Year 2016 and the establishment of the 2016 Pay-Go Capital Projects Ordinance.
