RESOLUTION AUTHORIZING ACCEPTANCE OF A 2020 HISTORIC PRESERVATION FUND MATCHING GRANT TO CONTINUE THE FORSYTH COUNTY ARCHITECTURAL SURVEY UPDATE FROM THE FORSYTH COUNTY HISTORIC RESOURCES COMMISSION (HRC)

WHEREAS the Forsyth County Historic Resources Commission (HRC) requests authorization to accept a grant from the National Park Services Historic Preservation Fund to continue the update of the county portion of the Forsyth County architectural survey which includes the unincorporated areas of Forsyth County, the Village of Clemmons, and the Towns of Kernersville, Lewisville, Bethania, Walkertown, and Rural Hall;

WHEREAS on June 29, 2018, the HRC was notified that the project was selected for funding in the amount of \$15,000 from the Historic Preservation Fund and subsequently received a second Historic Preservation Fund grant in the amount of \$20,000 in 2019, with half of each grant required to come from local funds, one-half from Forsyth County and the other half from the Village of Clemmons, and the Towns of Kernersville, Lewisville, Bethania, Walkertown, and Rural Hall (participating municipalities) collectively;

WHEREAS the proposed update will involve photographing, updating, and adding entries to the Forsyth County Architectural Survey database, and mapping both existing and newly identified historic properties constructed prior to 1971;

WHEREAS there are approximately 230 previously surveyed properties to update and approximately 5,000 properties constructed between the years 1930-1970, and the project will record properties constructed from 1930-1971 that are distinctive in their architecture or history, or threatened to be demolished due to development or lack of maintenance; and

WHEREAS the project will conclude with a report identifying properties eligible for the National Register, make recommendations of individual properties or neighborhoods for the National Register Study List, and identify candidates for the Forsyth County Local Historic Landmark Program;

NOW, THEREFORE BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Forsyth County Historic Resources Commission to accept a 2020 Historic Preservation Fund Matching Grant in the amount of \$30,000, with, \$7,500 from Forsyth County and \$7,500 collectively from participating municipalities, to continue the Forsyth County architectural survey update.
