SUMMARY OF INFORMATION:	
On August 6, 2020, the Forsyth County Board of Commissioners approved an amendment to the Fiscal Year 2021 Budget Ordinance to appropriate \$229,757.98 which Forsyth County received from the CARES Act Provider Relief Fund. The Forsyth County Emergency Services Department is proposing to enter into a contract with Stryker Sales Corporation for the purchase of four LUCAS Chest Compression System devices in an amount not to exceed \$76,540.32. These devices help with providing high-quality and safer chest compressions in situations such as patient movement and transportation during prolonged resuscitation attempts.	
This resolution approves the purchase of four LUCAS Chest Compression System devices under an exception to the bidding laws codified in N.C.G.S. 143-129(e)(6). Under these provisions, the bid procedures do not apply to purchases of apparatus, supplies, materials, or equipment when (i) performance or price competition for a product are not available; (ii) a needed product is available from only one source of supply; or (iii) standardization or compatibility is the overriding consideration.

WHEREAS Stryker Sales Corporation is the sole-source provider of the LUCAS Chest Compression System in the Hospital (hospitals and hospital-owned facilities), Emergency Response Services and Emergency Response Training (paramedics, professional and volunteer fire) markets in the United States; and

**WHEREAS** Forsyth County Emergency Services Department wishes to enter into an agreement with Stryker Sales Corporation for the purchase of four LUCAS Chest Compression System devices an amount not to exceed \$76,540.32;

**NOW, THEREFORE, BE IT RESOLVED,** by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, anagreementwith Stryker Sales Corporationfor the purchase of four LUCAS Chest Compression System devices an amount not to exceed \$76,540.32, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
