RESOLUTION AUTHORIZING QUANTUM MERUIT PAYMENT TO LEGAL AID OF NORTH CAROLINA, INC. FOR SERVICES PROVIDED TO SAFE ON SEVEN IN FISCAL YEAR 2019-2020

WHEREAS Legal Aid of North Carolina, Inc., has provided legal services by staffing Safe on Seven with a bi-lingual paralegal and part-time attorney from October 1, 2019, through December 31, 2019, for the benefit of Forsyth County;

WHEREAS Legal Aid of North Carolina, Inc. and Forsyth County had a contract for the services beginning on July 1, 2019 and ending on June 30, 2020; and

WHEREAS the cost of these services totaled \$18,350 for which the Company has not been compensated by the County;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby acknowledges that the legal services have been provided by Legal Aid of North Carolina, Inc., from October 1 through December 31 in the 2019-2020 fiscal year at a cost of \$18,350 for which the Company has not been compensated by the County;

BE IT FURTHER RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes payment by Forsyth County in the amount of \$18,350 to Legal Aid of North Carolina, Inc., for legal services by staffing Safe on Seven with a bi-lingual paralegal and part-time attorney during the fiscal year 2019-2020 on the basis of quantum meruit for the reasonable and just value of services rendered and acknowledged as a benefit to Forsyth County and for which the County received the benefits with the expectation of payment being made for services; and

BE IT FURTHER RESOLVED, that the County Chief Financial Officer is hereby authorized and directed to make payment as provided herein to Legal Aid of North Carolina, Inc., based upon acceptable written documentation submitted by the said provider.
