**WHEREAS** N.C.G.S. 143-318.12 requires the new meeting schedule to be filed with the Clerk to the Board of County Commissioners for at least seven (7) calendar days before the day of the first meeting held pursuant to the revised schedule and to post the schedule of regular meetings to the County's website; and

**WHEREAS** the Forsyth County Board of Commissioners proposes to adopt the attached revised Forsyth County Board of Commissioners' Meeting Schedule for its regular Board meetings and briefing sessions scheduled in June and July 2021;

**NOW, THEREFORE, BE IT RESOLVED**, that the Forsyth County Board of Commissioners hereby adopts the attached revised Meeting Schedule for 2021, which is incorporated herein by reference, and that Board meetings and briefing sessions will be held in the County Commissioners Meeting Room on the fifth floor of the Forsyth County Government Center located at 201 North Chestnut Street, Winston-Salem, North Carolina; and the Board directs the Clerk to the Board of County Commissioners to provide such notice of the Meeting Schedule as set forth hereinabove.
