WHEREAS, the North Carolina Department of Public Safety — Division of Juvenile Justice has awarded Forsyth County a Juvenile Crime Prevention Council (JCPC) Level II Dispositional Alternatives Grant, on behalf of its Juvenile Crime Prevention Council, in the amount of \$135,829 for a Family Therapy Program to be administered by Family Services, Inc. to serve at risk youth in Forsyth County.
