RESOLUTION APPROVING THE AMOUNT TO BE SPENT BY THE WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION TO ACQUIRE REAL PROPERTY TO BE USED FOR FUTURE IMPROVEMENTS AT THE SOUTHWEST ELEMENTARY SCHOOL SITE (TAX BLOCK 4428, LOT 306 (PIN 5894-07-9043.00)) (6460 HOLDER ROAD, CLEMMONS, N.C.)

WHEREAS, the provisions of N.C.G.S. 115C-426(f) require the approval by the Board of County Commissioners as to the amount to be spent by the Board of Education for school sites prior to the execution of a contract by the Board of Education for the purchase of a site or the expenditure of funds therefor; and

WHEREAS, on August 20, 2013, the Winston-Salem/Forsyth County Board of Education adopted a Resolution to exercise an Option to Purchase Real Estate relating to real property consisting of approximately 2.91 acres owned by Arvel Spease Hensley, to be used for future improvements at the Southwest Elementary School site, which property is located at 6460 Holder Road, Clemmons, N.C. and is further described as Tax Block 4428, Lot 306 (PIN 5894-07-9043.00), on the Forsyth County Registry, subject to approval by the Forsyth County Board of Commissioners of the amount to be spent on the site as required by law; and

WHEREAS, the Winston-Salem/Forsyth County Board of Education requests that the Forsyth County Board of Commissioners approve One Hundred Thirty-Six Thousand Seven Hundred Seventy and 00/100 Dollars (\$136,770.00) as the amount to be spent to purchase the above-described real property.

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby approves the total amount of One Hundred Thirty-Six Thousand Seven Hundred Seventy and 00/100 Dollars (\$136,770.00) to be spent by the Winston-Salem/Forsyth County Board of Education for the purchase of approximately 2.91 acres owned by Arvel Spease Hensley, which property is located at 6460 Holder Road, Clemmons, N.C. and is further described as Tax Block 4428, Lot 306 (PIN 5894-07-9043.00), on the Forsyth County Registry and to be used for future improvements at the Southwest Elementary School site.

BACKGROUND INFORMATION:

This is a corrected agenda page. The Resolution submitted to the Board for approval on August 20, 2013, reflected an incorrect purchase price of \$130,950.00, although the option included with the Board's materials had the correct purchase price of \$136,770.00.

On June 19, 2013, the Board of Education executed an Option to Purchase Real Estate for real property owned by Arvel Spease Hensley, such property known as a portion of Lot 306, Tax Block 4428, Forsyth County Registry. Staff recommends the Board of Education execute the Option and proceed with purchase of this real property associated with the future expansion of the Southeast site. The purchase price of the real property is \$136,770.00.

In accordance with N.C.G.S. § 115C-426, the Board of Education must obtain the approval of the Board of Forsyth County Commissioners regarding the amount to be paid for the acquisition of this real property.

SUPERINTENDENT'S RECOMMENDATION:

- 1. That the Board of Education exercise an Option to Purchase Real Estate for the purpose of acquiring real property owned by Arvel Spease Hensley, such property known as a portion of Lot 306, Tax Block 4428 (PIN 5894-07-9043.00).
- 2. That the Board of Education seek approval from the Board of County Commissioners of Forsyth County, pursuant to N.C.G.S. § 115C-426, for the acquisition of the parcel described hereinabove at the agreed upon sum set forth in the Option agreement.
