SUMMARY OF INFORMATION:

Due to State funding cuts to Forsyth County's Home and Community Care Block Grant (HCCBG), the Piedmont Triad Regional Council, as the Area Agency on Aging, and the Forsyth County Aging Services Planning Committee recommend the following plan funding decreases: \$1,447 to Mount Zion; \$2,170 to Senior Financial Care; \$13,742 to Senior Services; \$4,340 Shepherd's Center; and \$7,233 to Trans Aid. The decreases total \$28,932.

This resolution authorizes the submission of a revised HCCBG plan to the State.
