RESOLUTION AWARDING A CONTRACT FOR PURCHASE AND INSTALLATION OF A SECURITY SYSTEM AT THE FORSYTH COUNTY CENTRAL LIBRARY (GENERAL SERVICES DEPARTMENT)

WHEREAS, it is the recommendation of the County Manager, General Services Director, and the Purchasing Director that a contract for the purchase and installation of a security system for the Forsyth County Central Library at the base bid amount of \$185,700.44 be awarded to Strategic Security Solutions, L.L.C.
