- 4. Residency Requirement (State Senate 2 years in State, 1 year in district, NC Const., Art. II, Sec. 6); (State House, 1 year in district, NC Const., Art. II, Sec. 7); County Commissioner and Superior Court Judges must reside in the district; Congress NC resident, do not need to reside in the district.
