I. Introduction

In 1993, the North Carolina General Assembly established a network of local Child Fatality Prevention Teams (CFPT's) across the state to confidentially review medical examiner reports, death certificates and other records of deceased residents under age 18. Each local team consists of representatives of public and nonpublic agencies in the community such as law enforcement, Guardian Ad Litem, health department, among others, that provide services to children and their families (Appendix, Table1).

The purpose of this report is to give a summary of the causes of death, the number of cases reviewed, recommendations for prevention, if any, that have been made, and to share local team activities and accomplishments for the 2020 calendar year.

III. 2019 Child Deaths by Cause, System Issues Identified, Recommendations for Prevention & Proposed Action

In 2020, the Forsyth County CFPT Subcommittee received 53 child death cases from the 2019 calendar year for review. The number of child death cases received for review was unchanged from the 2018 calendar year (see Appendix, Figure 1, Page 6).

Key Characteristics:

- Forty-two (79.2%) of the cases received for review were infants (Appendix, Table 2, Page 7).
- Cause of Death:
 - **4** Extreme immaturity/prematurity/congenital abnormalities: 37 (69.8%)
 - **4** Illness: 4 (7.5%)
 - **4** Suicide (gun): 1 (1.9%)
 - Unsafe sleep/co-sleeping: 5 (9.4%)
 - **↓** Homicide (gun): 6 (11.3%)

In general, the Subcommittee recommends cases for a Full Team Review when the information gathered suggests that any of the following may have negatively influenced a child's health outcome:

- Lack of or inadequate communication between agencies and/or the child's parent or guardian regarding services
- Current rules or regulations did not adequately protect the child
- Abuse or neglect
- Mental health issues and/or developmental disabilities
- Alcohol, tobacco, and/or illegal drug use during pregnancy
- Unsafe sleep/co-sleeping

Of the 53 cases reviewed in Subcommittee, 12 were submitted for a Full Team Review.

The system issues identified, recommendations and proposed actions are summarized based on cause of death. The summary breakdown by cause of death is homicide (6), suicide (1), and unsafe sleep/co-sleeping (5).

IV. Forsyth County CFPT Activities and Accomplishments

Between January and February, 2020, CFPT/Forsyth County Infant Mortality Reduction Coalition (FCIMRC) organized and recruited 10 Forsyth County pediatric providers who agreed to discuss safe/unsafe sleep with parents and infant caregivers who visited their practice. Also, they agreed to include handouts about safe/unsafe sleep in their end of visit instructions to parents and caregivers,
