QUALIFICATIONS TO HOLD OFFICE

- 1. Registered Voter.
- 2. Twenty-one (21) years of age; NC Const., Art. VI, sec. 6 (Exceptions 25 years of age State Senate; NC Const., Art. II, Sec. 6).
- 3. Affiliated with a political party for 90 days by the date of filing the Notice of Candidacy (i.e. if filing on last day of filing period, party affiliation must have been changed by December 4,2021).
- Residency Requirement (State Senate 2 years in State, 1 year in district, NC Const., Art. II, Sec. 6); (State House, 1 year in district, NC Const., Art. II, Sec. 7); County Commissioner and Superior Court Judges must reside in the district; Congress – NC resident, residence not required in the district.
- 5. District Attorney and District Court Judges must be authorized to practice law in North Carolina court (NC Const., Art. II, Sec 18 & 22).
- Sheriff cannot practice law (NCGS 162-2), serve in the North Carolina General Assembly (NC Const., Art VII, Sec 2) and have been convicted
 of a felony. Any individual filing notice of candidacy must provide a Disclosure Statement prepared by the North Carolina Sheriffs' Education and Training
 Standards Commission.
- **The filing fee is calculated by one percent of the annual starting salary of the office.
- *** Deadline for all candidates to withdraw Notice of Candidacy March 1, 2022.
- ****Deadline for Soil and Water candidates to withdraw Notice of Candidacy June 29, 2022.
